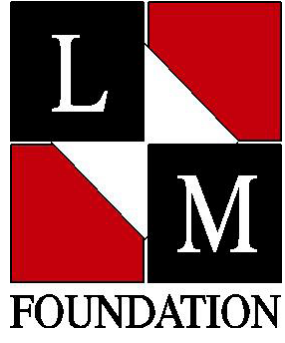


# LINN-MAR SCHOOL FOUNDATION HONOR ROLL OF DONORS
